Trustees of the Lettie Pate Evans Foundation are particularly sensitive to the needs of the Restricted Fund's supported organizations because they have all served as members of the governing boards of certain supported organizations. The Chairman of the Evans Foundation currently serves as a trustee of a supported organization. Other trustees continue to serve as emeritus trustees of supported organizations and attend meetings of the governing boards as non-voting members. Income from the Evans Restricted Fund is distributed in grants apportioned according to a formula prescribed in the will of Ms. Lettie Pate Evans. Supported organizations maintain full discretion in using that income even if no discretion exists for the Restricted Fund to alter the formula by which grants are made.

Trustees and executive leadership of the supported organizations meet regularly with Restricted Fund leadership to discuss the Fund's investment philosophy, asset allocation and investment returns. Each of the supported organizations that receives a percentage of the Restricted Fund's annual income regularly expresses its interest in maintaining a reliable, steadily growing income stream from the Restricted Fund. And each regularly express support for the Restricted Fund's record of growing distributions by an average of 10% annually over the past forty years. The Restricted Fund provides audited financial statements annually to the supported organizations. Based on the trustees' first-hand knowledge of the needs of the supported organizations and discussions with executive leadership of the supported organizations, the Restricted Fund has maintained an investment policy that seeks reliable, steady growth in income over
